

WHAT THIS PRIVACY POLICY COVERS

This policy covers how Blogger at Large treats personal information that Blogger at Large collects and receives, including information related to your past use of Blogger at Large products and services. Personal information is information about you that is personally identifiable like your name, address, email address, or phone number, and that is not otherwise publicly available.

This privacy policy only applies to Blogger at Large.

INFORMATION COLLECTION AND USE

Blogger at Large collects personal information when you register with Blogger at Large, when you use Blogger at Large products or services, when you visit Blogger at Large pages or the pages of certain Blogger at Large partners, and when you enter promotions or competitions. Blogger at Large may combine information about you that we have with information we obtain from business partners or other companies.

When you register we ask for information such as your name, email address, birth date, gender, post code, occupation, industry, and personal interests. When you register with Blogger at Large and sign in to our services, you are not anonymous to us.

Blogger at Large collects information about your transactions with us and with some of our business partners, including information about your use of financial products and services that we offer.

Blogger at Large automatically receives and records information from your computer and browser, including your IP address, Blogger at Large cookie information, software and hardware attributes, and the page you request.

Blogger at Large uses information for the following general purposes: to customise the advertising and content you see, fulfill your requests for products and services, improve our services, contact you, conduct research, and provide anonymous reporting for internal and external clients.

INFORMATION SHARING AND DISCLOSURE

Blogger at Large does not rent, sell, or share personal information about you with other people or non-affiliated companies except to provide products or services you've requested, when we have your permission, or under the following circumstances:

We provide the information to trusted partners who work on behalf of or with Blogger at Large under confidentiality agreements. These companies may use your personal information to help Blogger at Large communicate with you about offers from Blogger at Large and our marketing partners. However, these companies do not have any independent right to share this information.

We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims.

We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Blogger at Large's terms of use, or as otherwise required by law.

We transfer information about you if Blogger at Large is acquired by or merged with another company. In this event, Blogger at Large will notify you before information about you is transferred and becomes subject to a different privacy policy.

Blogger at Large displays targeted advertisements based on personal information. Advertisers (including ad serving companies) may assume that people who interact with, view, or click targeted ads meet the targeting criteria—for example, women ages 18-24 from a particular geographic area.

We limit access to personal information about you to employees who we believe reasonably need to come into contact with that information to provide products or services to you or in order to do their jobs.

We have physical, electronic, and procedural safeguards that comply with legal regulations to protect personal information about you.
